

THE GREAT ROAD TRIP GIVEAWAY

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

GIVEAWAY ENTRY PERIOD: The Great Road Trip Giveaway (the "Giveaway") begins on Wednesday, April 24, 2019 and ends on Wednesday, September 11, 2019 (the "Giveaway Period").

ELIGIBILITY: The Giveaway is open to legal residents of the 50 United States (excluding New York and Florida), including the District of Columbia, who are age 21 or older at the time of entry. Void in Florida, New York, Puerto Rico, Guam, the U.S. Virgin Islands, outside the U.S., and wherever else prohibited by law. Employees of Ackerman McQueen (the "Sponsor"), US Sweepstakes & Fulfillment Company (the "Sweepstakes Administrator"), and their respective subsidiaries, affiliates, advertising and promotion agencies, and the immediate family members (spouses, parents, children, and siblings and their spouses) of, and/or those living in the same household of each, are not eligible to enter. Giveaway is subject to all applicable federal, state and local laws and regulations.

HOW TO ENTER: There are two (2) ways to enter.

After at least twenty (20) Stamp Card stamps have been received, mail your completed Stamp Card to: **The Great Road Trip Giveaway, Post Office Box 5592, Ellenton, FL 34222** to receive one (1) entry into the Giveaway (the "Stamp Card Entry"). **Stamp Card Entries must be mailed separately and must be postmarked between Wednesday, April 24, 2019 and Wednesday, September 11, 2019, and received by Wednesday, September 18, 2019.** Entrants are subject to all notices posted online including but not limited to the Sponsor's Privacy Policy, which can be found at https://www.adventureroad.com/media/2411/adventureroad_termsfuseandprivacypolicy.pdf.

To request a Stamp Card by mail, visit www.adventureroad.com/giveaways/great-road-trip-giveaway-2019 and complete the form in its entirety. The last date to submit an online request to receive a Stamp Card by mail is Wednesday, August 28, 2019. Requested Stamp Cards will be mailed within three (3) business days of the date of request.

CTS gift card offer: For every completed Stamp Card Entry that meets the eligibility requirements, entrant will receive one (1) \$25 CTS gift card ("Gift Card"). Limit: one (1) Gift Card per person.

Gift Cards are not redeemable for cash and will not be replaced if lost or stolen. Gift Card usage is subject to the issuing company's complete terms and conditions, including expiration dates.

Gift Card will be sent to the address on the Stamp Card Entry within 4-6 weeks of receipt and verification. Photocopied, illegible, or mechanically reproduced entries are not eligible. All entries become the property of the Sponsor and will not be returned or acknowledged. Sponsor is not responsible for lost, late, damaged, misdirected or postage-due mailed entries.

Only entrants that submit a Stamp Card Entry (Method #1) will receive a Gift Card.

Method #2: Alternate Method of Entry ("AMOE") / Mail-in Entry. Limit: One (1) Entry per person during the Giveaway Period regardless of method of entry. All entries become the property of the Sponsor and will not be acknowledged or returned.

PRIZE/APPROXIMATE RETAIL VALUE ("ARV")/ODDS:

Grand Prize: There is one (1) Grand Prize available to be won. Grand Prize is one (1) vehicle of winners' choice, up to a maximum of \$75,000. Winner will be responsible for coordinating with a car dealership of his/her choice, subject to Sponsor approval. Winner will be responsible for any and all costs associated with the collection and use of the vehicle, including but not limited to, optional equipment and any other costs over the stated maximum of \$75,000, freight and dealer prep, title, license, insurance, registration fees, applicable taxes and any travel and transportation costs associated with collecting the vehicle. All other costs not specifically stated herein are the responsibility of the winner. Winner must have proof of a valid U.S. driver's license from his or her State or place of residence in the United States and must have proof of insurance to dealership satisfaction to take delivery of vehicle. Winner is subject to any additional terms or conditions of purchase for the selected dealership. Noncompliance may result in forfeiture of prize.

Winner will have the option to select a \$45,000 cash alternative in lieu of vehicle.

The maximum ARV of Grand Prize: \$75,000.

The total maximum ARV of all prizes available to be won: \$75,000.

Odds of winning will depend upon the total number of eligible entries received.

RANDOM DRAWING: The winner will be selected in a random drawing on or about **Monday, September 23, 2019** from among all eligible entries received during the Giveaway Period by the Sweepstakes Administrator, an independent representative of the Sponsor whose decisions are final.

WINNER NOTIFICATION & VERIFICATION: Potential Grand Prize winner will be notified via email and/or phone, and will be required to sign and return, within seven (7) days of notification, an Affidavit of Eligibility, a Liability Waiver, an IRS W-9 Form and where allowable, a Publicity Release (collectively, "the Releases"). These Releases will require the Grand Prize winner to furnish his/her Social Security Number for the sole purpose of tax reporting, as required by law. Noncompliance will result in disqualification and an alternate winner may be selected. Winner must select vehicle and complete all dealership requirements within 30 days of winner verification and provide vehicle purchase documents to Sponsor for payment to dealership within 45 days of winner verification.

If a prize notification or prize is returned as undeliverable, or if winner is found to be ineligible or not in compliance with these rules that winner will be disqualified, and the prize may be awarded to an alternate winner in a separate random drawing. DISPUTES: The parties hereto each agree to finally settle all disputes only through arbitration; provided, however, the Released Parties shall be entitled to seek injunctive or equitable relief in the state and federal courts in Oklahoma County, Oklahoma and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Giveaway shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in Oklahoma County, Oklahoma. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in Oklahoma County, Oklahoma. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.
