

## AdventureRoad.com "GIRLS' WEEKEND GIVEAWAY" Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY REGULATION OR LAW. PARTICIPANTS MUST BE 18 YEARS OF AGE OR OLDER. Internet access and a valid, active email account are required.
